**Eligibility for Election and Eligibility to Vote are set out in – By-Law 1, Sections 8 (Women), 9 (Juniors), 10 (Amateurs), 11 (Premier & State Leagues) and 12 (Futsal)**

In general terms,

- a person is eligible to be a member of an Advisory Group if they are:

- a) 18 years of age or over; and
- b) Nominated according to rule 13.4 of this By-Law

- Eligible to vote if they are a Club or Association that fields a team that participates in [Amateur/ Futsal/ Junior/ Premier & State League / Women's] football, sanctioned by Football South Australia for this purpose.

**Nominations – By-Law 1, rule 13.4**

- (c) A person is only eligible to be nominated as a candidate for election as a member of an Advisory Group if that person:
  - (i) is eligible for election to the relevant Advisory Group according to the By-laws;
  - (ii) is not presently a member of a Zone Council except where his or her term of office will expire at an election being held concurrently with the Advisory Group election;
  - (iii) has not been nominated in any election being held in the same year, as a candidate for election as a member of a Zone Council;
  - (iv) is not presently a member of any other Advisory Group, except where his or her term of office will expire at an election being held concurrently with the Advisory Group election;
  - (v) has not been nominated in any election being held in the same year, as a candidate for election as a member of another Advisory Group;
  - (vi) does not hold a position as an officer or employee of FFA or Football South Australia.
- (d) A candidate for election as a member of a Zone Council or an Advisory Committee may only be nominated by a person eligible to vote in the relevant election according to this By-law.
- (f) Where a Club nominates a person as a candidate for election as a member of a Zone Council or Advisory Committee, that person must be nominated on behalf of the Club by the formal electoral contact of the Club for the relevant Interest appointed according to rule 13.3 of this By-law.
- (g) A nomination must:
  - (i) be in writing;
  - (ii) be signed by the nominator or nominators and the candidate;
  - (iii) if the election is for a Advisory Committee, specify the Advisory Committee in respect of which the candidate is standing for election;
  - (iv) if the election is for a Zone Council, specify the Zone Council in respect of which the candidate is standing for election and the Interest for which the candidate is nominated;
  - (v) be lodged at the Registered Office by the time and date specified in the Notice.

**Functions of Advisory Groups are set out in By-Laws 5 (Women), 6 (Futsal), 7 (Juniors), 8 (Premier & State Leagues) and 9 (Amateurs)**

In general terms the role of each Advisory Group is to provide strategic advice and where appropriate recommendations to Football South Australia and its Chief Executive on measures and policies to promote, develop and improve football for that Interest Group, including through the identification and development of talented players, and at the same time taking account of any national framework or curriculum.

**Membership – section 6 of By-Laws 5 (Women), 6 (Futsal), 7 (Juniors), 8 (Premier & State Leagues) and 9 (Amateurs)**

In general terms, Advisory Groups will:

- (a) comprise nine persons;
- (b) have a minimum of two representatives from each Zone; and
- (c) be elected or appointed according to By-laws
