

## Football SA 2024 Competition Regulations

Summary of Changes – Girls and Women's Operations Regulations

Definitions	Add: Pre-season competition, not official competition. Membership applications – move as a rule as per junior boys.	Provide clarification that the pre-season competition is not official for the purposes of match statistics.

19(1)	Any appointed Match Official shall be responsible for reporting the result of each match, the goal scorers and any other information that may be required by Football SA.	Amendment made as all appointed match officials must complete all match day statistical information.
(2)	The result of all matches must be submitted online in the Football SA Competition Management System by the home club. Where no match official is present, the home club must submit the results and statistics no later than one (1) hour post completion of the match.	All match information is to be completed by the HOME team no later than one (1) hour after the completion of the match.
(3)	If a club dispute any of the match information on Dribl, they must submit a dispute on Dribl with reasons. Any dispute must be submitted no later than 48 hours of the scheduled kick-off. Football SA will review all submitted disputes and make determination in its sole and absolute discretion.	Provide clarity relating to the process for match day information disputes.

36(e)	New subclause: Once a player has played in the girls cup competition, they are not permitted to play in the boys cup competition. Once a player has played in the boys cup competition, they are not permitted to play in the girls cup competition.	Provide clarity for players which participate across both boys and girls competitions.
38.(1)	Include WSL	To reflect WSL competition utilising substitutes from the 2024 Season.
43. (2)	If a WNPL or WSL First Team forfeits a cup match, three (3) competition points will be deducted from the league table.	Season 2023 experienced many forfeits by Senior Teams in the cup competition. This rule amendment will discourage teams from forfeiting cup matches.

(8)(c)	Penalty for playing a registered and eligible player, not named on a team sheet, has been reduced to a fine for the first offence, forfeit for any subsequent offence.	Multiple forfeits applied throughout the 2023 season were a result of administration error and did not provide any unfair competitive advantage. Multiple forfeits for administration errors can affect the integrity of the competition and it is agreed results on the field should stand where no competition advantage is gained.
