

## Football SA 2024 Competition Regulations

<b>Throughout document</b>	Amend 'he or she' to 'they'.  Amend 'team sheet' to 'match sheet'.	Gender neutral pronouns.  Updated to reference dribl terminology.
<b>1.6</b>	Rule moved from 8.(1) to 1.(6).	Rule is better positioned under Team Nominations.
<b>3. (3)</b>	Add: All registered coaches must have a valid DCSI Working with Children Check.	Provide further clarity on clearances required for coaches.
<b>5.</b>	Add MiniRoo's game duration.	Provide additional information.

<p><b>8. (1)</b></p>	<p>Add wording, "This rule does not apply to players moving to a higher grade or age group."</p>	<p>Provide further clarity.</p>
<p><b>9. (2)</b></p> <p><b>(4)</b></p> <p><b>(5)</b></p> <p><b>(6)</b></p>	<p>No requests will be sanctioned by Football SA within seven (7) days of the fixture unless there are exceptional circumstances exist.</p> <p>The result of all matches must be submitted online in the Football SA Competition Management System by the home club, where no match official is present, no later than one (1) hour post completion of the match.</p> <p>Remove clause.</p> <p>New Clause: If a club disputes any of the information submitted on Dribl, they must submit a dispute on Dribl with reasons for the dispute. Any dispute must be submitted no later than 48 hours of the scheduled kick-off. Football SA will review all submitted disputes and make determination in its sole and absolute discretion.</p>	<p>Provide clarity.</p> <p>Amended to incorporate Dribl process.</p> <p>No longer valid with use of Dribl.</p> <p>Provide process for dispute on Dribl.</p>

(4)</b></p>   <p><b>(5) (c)</b></p>   <p><b>(d)</b></p>	<p>If an appointed Referee does not attend the match, the Home Club must inform Football SA within 24 hours of the scheduled fixture.</p>  <p>New clause:</p> <p>The home team must list the Club appointed match official within the Football SA Competition Management System as a non-accredited referee.</p>  <p>If a Club referee is appointed, they must ensure that both teams have submitted and confirmed the match sheets in the Competition Management System. No game should proceed until the match sheets have been confirmed.</p>	<p>Reduced from 48 hours to 24 to ensure payments are processed prior to Football SA being informed.</p>   <p>To ensure a record exists of club appointed referees.</p>   <p>Ensure process is followed by club appointed match official.</p>
<p><b>16. (2)</b></p>	<p>In the event of a draw at the end of normal time in all Junior Cup Competitions, the match will be determined by penalty kicks in accordance with the FIFA Laws of the Game.</p>	<p>Remove extra time for junior cup matches.</p>
