**FOOTBALL SA – ASSESSMENT CRITERIA FOR CLUB INCLUSION 2025**

**1. Background**

---

- 1.1 Football SA will assess Clubs suitability for participation in the Senior Men's Competitions in accordance with these guideline in its ultimate discretion.
- 1.2 The Senior Men's Competitions includes the RAA National Premier League, State League 1 and State League 2 Competition and any other competition Football SA determines from time to time.
- 1.3 Clubs must satisfy the minimum standards for the relevant competition as prescribed by Football SA (refer *Football SA Senior Men's Operating Regulations*) prior to promotion into each competition.
- 1.4 Clubs are required to enter into a standard Club Participation Licence Agreement with Football SA with respect to its participation in Football SA competitions.

**2. Assessment**

---

- 2.1 In assessing Club applications pursuant to these guidelines, Football SA will consider a range of factors including but not limited to:
  - (a) the maximum number of teams which will participate in the relevant competitions;

- (b) the Club's ability to comply with current and future minimum standards as prescribed by Football SA, Football Australia and FIFA for the relevant competitions;
- (c) the geographical location of the Club, including proximity to existing Clubs in the relevant competition, the current population base and forecast population growth;
- (d) the Club's vision and strategic plan;
- (e) the Club's current governance and administration structure;
- (f) the preferred alignment of male and female teams;
- (g) the Club's history of compliance with Football SA and affiliated associations Rules and Regulations;
- (h) the Club's financial viability, including operating budgets and net asset position;
- (i) the Club's relationship with local government;
- (j) the Club's junior pathway programs.

### 3. Process

---

- 3.1 Clubs seeking entry – or otherwise at the request of Football SA – must submit an application via the prescribed form (Appendix A) addressing all required areas by **COB, Friday 26 July 2024**.
- 3.2 Football SA will then assess all applications and advise Clubs of the outcome.
- 3.3 Football SA will formally invite Clubs to participate in the Senior Men's Competition once the process is complete.
- 3.4 Invited Clubs, if accepted, will enter the Senior Men's Competition from the lowest division (currently State League 2).

7.2	Registration	The Club must ensure all players, coaches and volunteers are registered via the National Registration System (PlayFootball)	Requirement under Football Australia & Football SA Rules and Regulations.	2025

7.3	Business Plan	The Club has a 3-year strategic plan, approved by the Board or committee of the Club.	Provides the Club with a strategic plan with clear actions to achieve its goals.	2025
7.4	Annual General Meeting	The Club must hold an Annual General Meeting in accordance with applicable legislation at which all Members shall be entitled to attend and participate.	Legislative requirement.	2025
7.5	FIFA, Football Australia and Football SA Rules, Regulations and Policies	The Club must comply, at all times, with all FIFA, Football Australia and Football SA Rules, Regulations and Policies.	Requirement under Football SA Participation Licence.	2025

8.3	Inspection of Financial Records	The Club must make available to Football SA any financial information requested within 14 days of receiving notice of an inspection.	Rules and Regulations requirement.	2025
8.4	Accounting Systems	The Club must maintain accounting systems to enable it to properly maintain its financial records.	Assist the Club with effectively managing its finances.	2025

8.5	Football SA Accounts	The Club must be up to date with all payments to Football SA by October 31 in accordance with the Football SA Rules and Regulations.	Ensures the Club is solvent year on year.	2025

9.2	Lighting	The Club's home venue for matches must have a minimum lighting level of 100 lux and a minimum of 200 lux for RAA NPL teams.	Allows for night matches which provides flexibility on match day and increases capacity of venues.	2025
9.3	Fencing	Clubs in State League 1 and the RAA National Premier League are required to have pitch fencing and venue perimeter fencing should it be promoted to higher leagues.	Provides a safer environment for participants and spectators and allows Clubs to charge a gate.	Mandatory with promotion to higher leagues.



9.4	Players Race	Clubs in State League 1 and the RAA National Premier League are required to have a players race which extends from the Changeroom to pitch with unobstructed entry and exit from the field of play.	Provides a safer environment for participants to enter and exit the field of play.	Mandatory with promotion to higher leagues.

10.2	Supplies (Match Day & Training)	An appropriately and adequately stocked first aid kit and trainers kit, plus a stretcher that meets industry standards.	Important for player and spectator safety.	2025
