5.6 - Player Eligibility	Update clause regarding inability of Clubs to recruit more than 5 players from another team as this previously caused significant confusion with teams.	A club is not permitted to recruit more than five (5) players from another team that is affiliated with the Football SA competitions. If a club has recruited more than five (5) players from another team, they must demonstrate that there are exceptional circumstances for the Football SA to consider. Any decision will be at the discretion of the Football SA. This applies to all competitions.	Applies to Community and Youth Competitions only (per feedback from Football SA Competitions team).

Clause 5.18 - Movement of Players	The Movement of Players rule for the WNPL has been challenging to administer and has led to confusion. Men's movement rule which is based on the 75-minute rule has been adopted.	Previously the Regulations used a Cap rule in that a WNPL or WSL1 Club may move a maximum of four (4) Players between the Senior Grade and Reserve Grade on any given round of Matches on the proviso that the four Players were named as Substitutes in the Senior Grade Match.	Women's movement of player rule aligned with Men's eligibility in that once a player has played in that higher grade on that round, the player shall become ineligible to play in a lower grade for their club in the same round of matches (including the final series), unless the 75-minute rule is satisfied.

This approach ensures clarity while still retaining the rules applicable to both Cup Competitions.

Clause 12 – Penalties and Fines	The fine levels across the Men's, Women's, and Youth competitions were inconsistent, with differing monetary values assigned to the same fine level (e.g., a Level 2 fine in the Men's competition had a different value than a Level 2 fine in the Women's competition).	The varying fine levels across competitions made it confusing and difficult to determine the applicable fine amounts.	This clause, relating to the summary of fines and penalties, has been revised to standardise fine levels across all competitions – Men's, Women's, and Youth. There are now 9 consistent levels of fines applicable.

Clause 16 - Mandatory Match Suspension for Yellow Card offences.	Clarify accumulation of yellow cards and mandatory suspension to minimise ongoing confusion from rule.	Player receives mandatory match suspension of 1 Match if they accumulate 5 yellow cards. Yellow card accumulation limit increases from 5 to 8 cards at the conclusion of round 18, which is confusing as there may be rounds that are washed out and then played after the fixtured round 18.	 Consolidated all Mandatory Match Suspension provisions for Yellow Card Offences into the Disciplinary and Judicial Body Regulations, ensuring the content related to Disciplinary Regulations is maintained in a single section. A Player who receives 5 yellow cards is suspended for 1 Match, only if they were accumulated in community competitions i.e. if they get 4 in Community Matches and 1 in a non-Community Match, they are not suspended under this rule. Changed wording that yellow Card accumulation limit increases from 5 to 8 cards from "at the conclusion of round 18" to "after 18 rounds". If there are games that are postponed or washed out, there may be an occasion where an earlier round is played after Round 18. Eg, round 15 is washed out and played after round 18.
